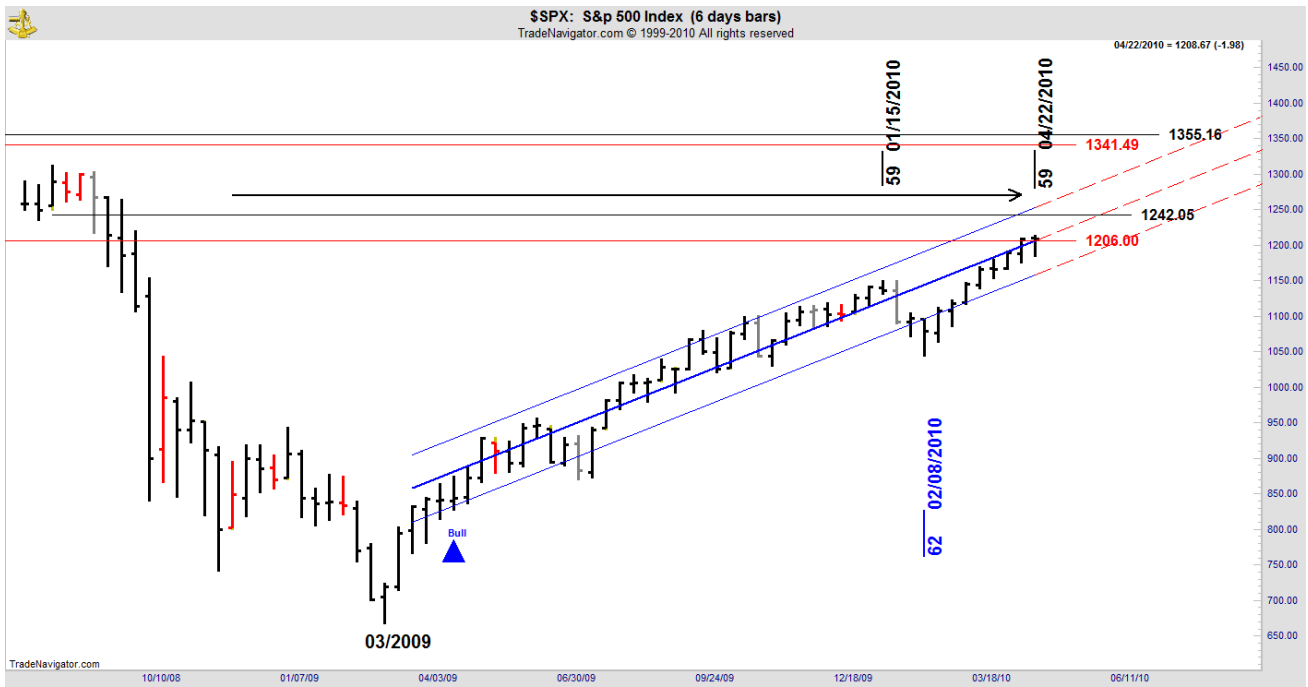

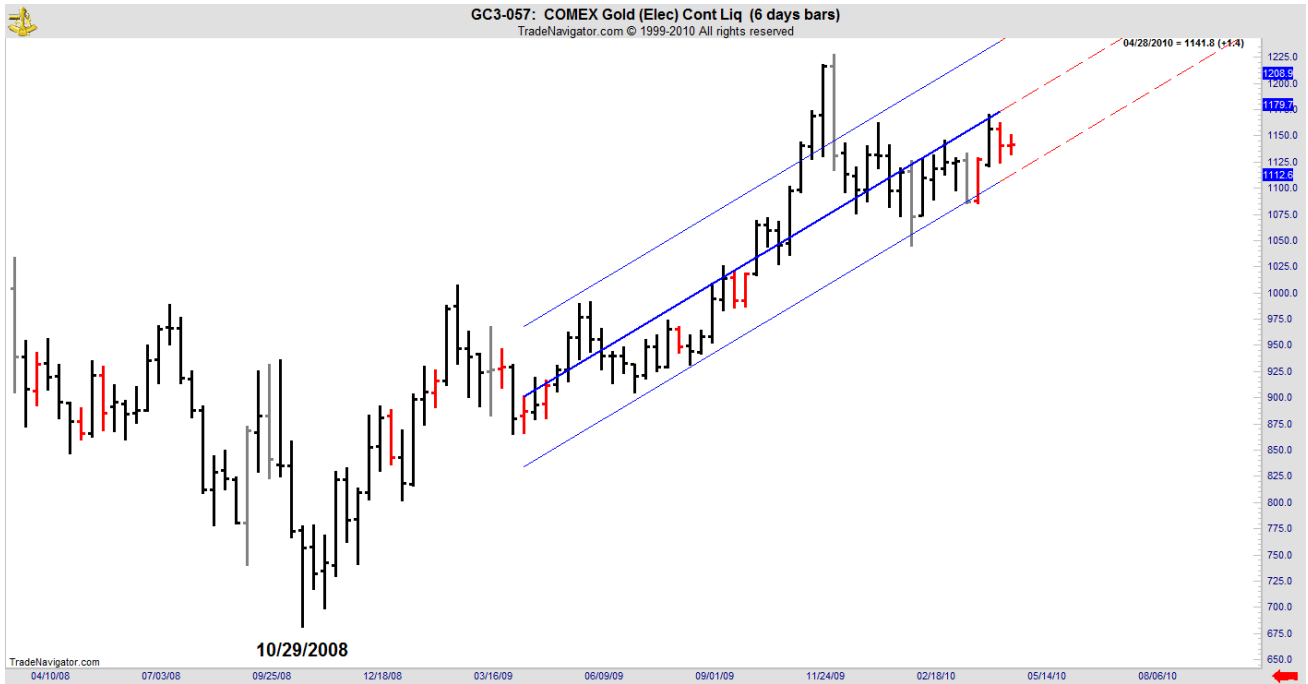
S&P

On 24 Day Regression Channel, Trend is: UP

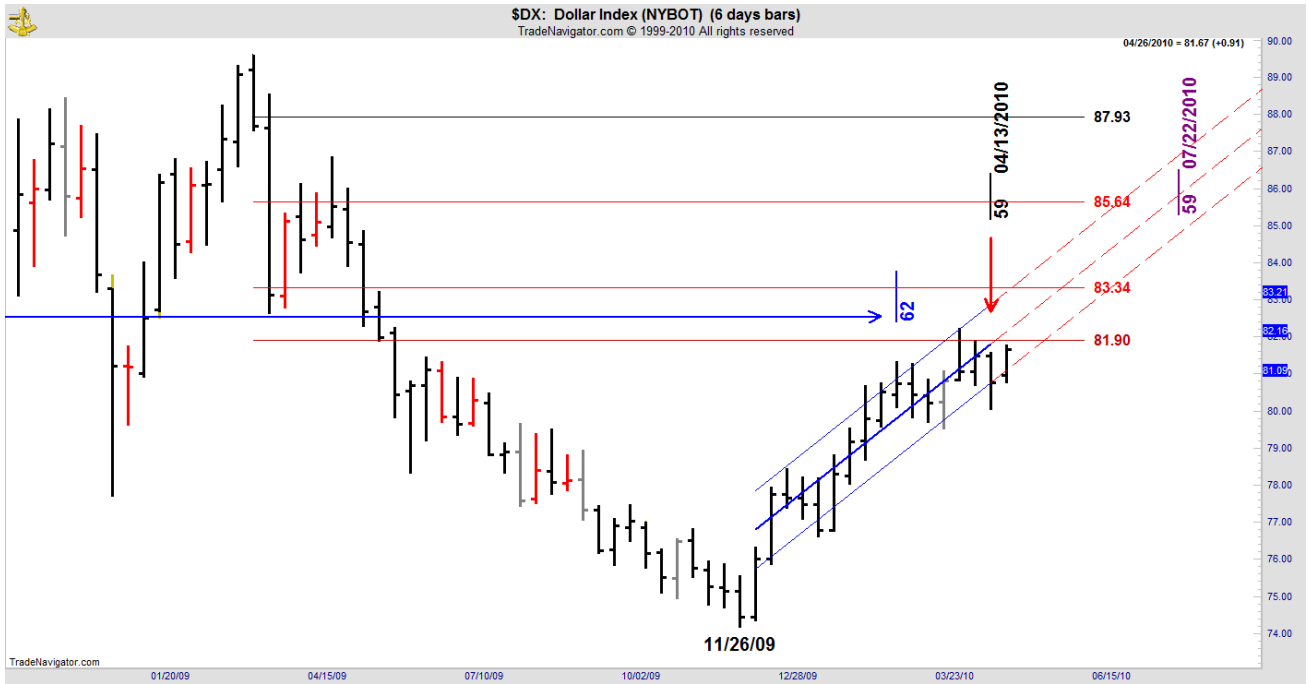


US Dollar Index (DX)

On 12 Day Regression Channel, Trend is: UP

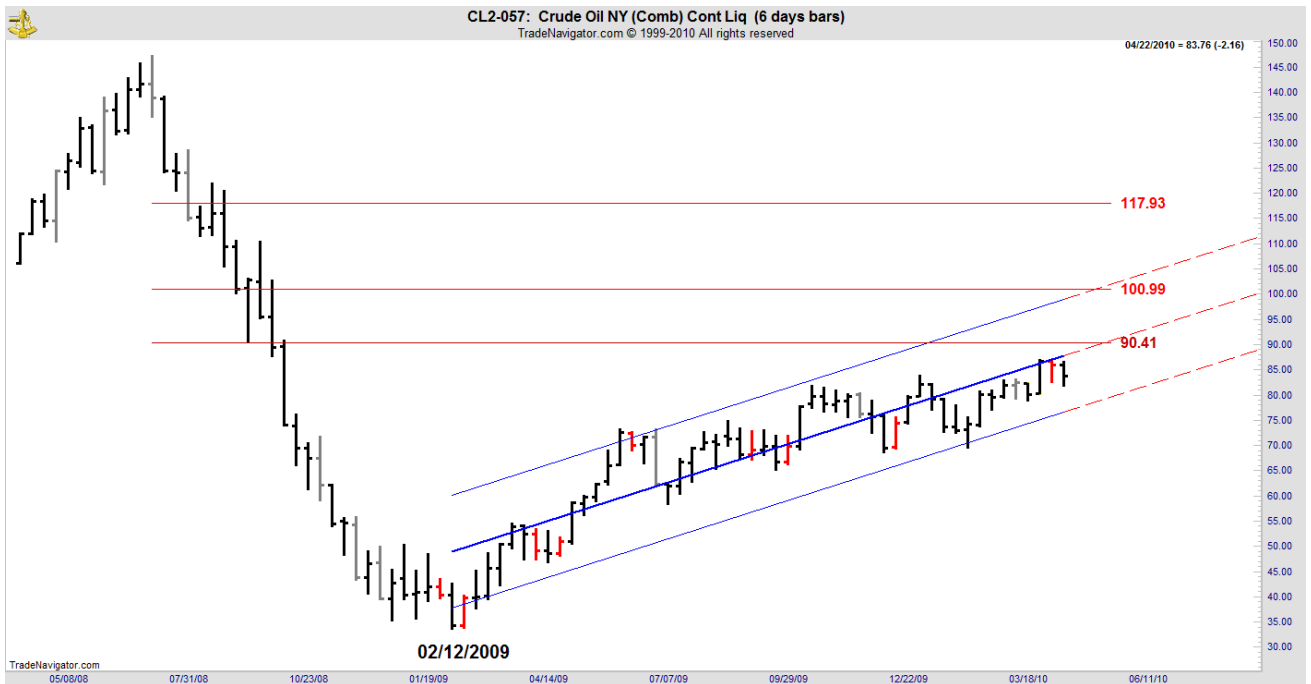
On 24 Day Regression Channel, Trend is: DOWN.

The 6 day chart has made a conditional Buy signal.
